## Specific Consent for Children to Appear in the Christmas Song Videos

Dear Parents and Carers,

This year, due to COVID-19 restrictions, we will be sharing our Christmas performances with parents and carers virtually. We plan to film each class singing their Christmas song on **Tuesday 8<sup>th</sup> December** and publish this on our school's Youtube page as an unlisted video. An unlisted Youtube video is still public, however only those who have the link to the video can view it. I am writing to inform you of this and ask permission for your child's involvement.

It is important that we protect your child's interests, respect your wishes and comply with Data Protection law. Please read the Conditions of Use below before completing, signing and dating the form. Please return the completed form (one for each child) to the school as soon as possible; we will not allow your child to be involved without your consent. From today, there will be a drop-off box at the main gates on Thornhill Road each day for consent forms to be returned. **Deadline to return the consent forms is Monday 7<sup>th</sup> December at 9:45am.**

Please note that you can withdraw your consent at any time for your child not to appear in the Christmas song video however, **the video will not be removed from Youtube until 02/12/2022**.
